### **Winter Precautions**

Welcome to a chilly 2017. January is usually a quiet month for lettings and there are many more properties left standing empty. A reminder for clerks, landlords and letting agents: don't forget that heating should be left on a low temperature to stop pipes freezing and therefore invalidating the landlords insurance.

If a property is to be empty for long periods the system needs to be drained down for safety. In winter periods we all need to have a previously devised strategy to keep empty properties safe and secure.

### **Data Protection**

Whilst Letting Agents are required to register under the Data Protection Act as they hold personal identifiable information. The AIIC, as a not for profit organisation, does not need to register for data protection with the Information Commissioner's Office (ICO).

Following enquiries from some of our members we have discussed this issue with the ICO. Clerks (and the AIIC) are classed as 'processors' of the personal information that we collect. The AIIC has been assured that Clerks are not required to register. #### **TDS Foundation Funds Available**
